LICENSE AND RELEASE OF LIABILITY

I hereby irrevocably agree and consent that Dan Group LLC, a Connecticut limited liability company, d/b/a danPhotoArt and its affiliates, successors and assigns (collectively, "DANGROUP"), is authorized to use and has the exclusive worldwide right and license to use, all or any part of all paintings, portraits, photographs, and other reproductions, and any derivative works thereof (collectively, the "Photos") heretofore created by DANGROUP or made available by me to DANGROUP, including but not limited to any artwork, painting or other graphic material derived from any Photo, in connection with any live or graphic presentation, computer software product, CD-ROM, or World Wide Web site on the Internet, or in any other tangible or intangible medium whatsoever, and in any advertising or promotional material. To the extent that any Photo is not a "work made for hire", I hereby irrevocably and unconditionally assign to DANGROUP all of my right, title and interest in and to such Photo.

The rights granted DANGROUP are perpetual, worldwide, irrevocable, unconditional, transferable, and include the use of the Photos in any medium (all or part of the Photo may be shown), whether now in existence or later discovered, including but not limited to print, radio, broadcast and cable television, audio and video cassettes, the Internet, broadband, CD-ROM, and live or slide presentations.

This consent and license is given as an inducement for DANGROUP to publish, broadcast and/or disseminate the Photos and I understand DANGROUP will incur substantial expense in reliance on this consent and license. DANGROUP is not obliged to make use of the Photos or exercise any of the rights granted DANGROUP by this release.
